After completing his service, Tim served as a law clerk to the Honorable J. Rolando Olvera of the U.S. District Court for the Southern District of Texas. He then practiced at a leading international law firm in Houston, where his work included complex commercial litigation, internal investigations, financial disputes, and technology-related matters, frequently involving major energy-sector clients and issues.

Tim graduated with honors from the Antonin Scalia Law School at George Mason University, where he served as Executive Editor on the George Mason Civil Rights Law Journal and as a Symposium Editor on the Harvard Journal of Law & Public Policy. He competed nationally as a member of the National Moot Court Team, earning honors at the National Moot Court Competition as Southeast Regional Champion and Best Oral Advocate and as National Quarterfinalist.
